If your instructions as to when the moneys shall be forwarded or transmitted are not complied with and the money has not yet been forwarded or transmitted, you have a right to a refund of your money. If you want a refund, you must mail or deliver your written request to WorldRemit Corp. at 600 17th St, Suite 200 South Denver, CO, 80202.
